The Community Foundation of Greater Fort Wayne connects people and resources to build a more vibrant community. We do this by doing three things; we help people make their charitable giving more impactful, we connect funding to effective nonprofits through grantmaking, and we provide leadership to address community needs and improve quality of life. 2019 was an exciting year for the Community Foundation as we engaged more donors, created more funds than we ever have in a year, and had an even bigger impact in Allen County than we did last year. For almost 100 years, the Community Foundation of Greater Fort Wayne has led the collective impact of nearly \$174,583,900 awarded in grants, 1,956 nonprofits who have received funding, and 4,655 donors supporting the causes they care about.

# The Gallegos-Blaettner Family Fund

The Gallegos-Blaettner Family Fund was founded in 2019 to provide students in STEM programs access to technology that they need to be successful in the classroom. The Gallegos-Blaettner Family first heard about the Community Foundation of Greater Fort Wayne from their financial planner. They decided that opening a fund at the Community Foundation was the best way for them to give back to the community and achieve their family philanthropic goals.

Toni and Harald work in engineering roles that depend heavily on technology. Had technology been as heavily relied on when they were younger as it is now, they are not sure this avenue would have been opened to them and they could have afforded to enter science and engineering fields for their careers. Toni and Harald first had the idea of donating calculators to local schools after seeing a mom buying several \$100 graphing calculators for her school aged children. They began wondering how families struggling to make ends meet would afford this pricey yet necessary tool for school. After hearing Toni and Harald's goals, the Community Foundation's Philanthropic Services team began to investigate how to accomplish the Blaettner's goals while making an impact for students. The Community Foundation learned that schools have calculators on loan for students who cannot afford to purchase them. However, there is a real need for chrome books to support students in continuing their education. After presenting the idea of donating chrome books instead of graphing calculators to the Gallegos-Blaettner Family, they were thrilled to help provide students with needed technology that they otherwise would not be able to afford.



## Grants and Scholarships

The Community Foundation of Greater Fort Wayne connects funding to effective nonprofits through grantmaking, while also providing education, training opportunities, and additional resources for Allen County Nonprofits.

#### \$2 Million Invested in Allen County Nonprofits

Since 1922, the Community Foundation has awarded \$174,583,900 in grants and 1,956 nonprofits have received funding. In 2019, the Community Foundation granted \$2 million in competitive grants to 100 Allen County nonprofits. In addition to funding, we also provide resources and services to help nonprofits become sustainable. We believe that nonprofits are the backbone of our community and provide essential services to make a stronger Allen County for all.

We funded nonprofits in our four giving areas: Arts and Culture, Community Development, Health and Human Services, and Youth and Education. In addition to the Community Foundation granting \$2 million in competitive grants, our donors gave over \$3 million from their funds held at the Community Foundation to nonprofits.



#### \$98,000 was Raised on Giving Tuesday!



Over \$98,000 was raised for Agency Endowments at the Community Foundation! Congratulations to Fort Wayne Sister Cities, Healthier Moms and Babies, ACRES Land Trust, and The Phil! They were the winners of the 2019 #GivingTuesdayFW Challenge and raised the most money for their endowments at the Community Foundation!

In order to do their work effectively, nonprofits need to not only rely on grant funding or individual gifts, but for true sustainability, need to be

supported by an endowment. Agency Endowment Funds are permanent funds wherein the initial gift and subsequent gifts are invested for long term growth. A percentage of earnings goes directly to the nonprofit to support their organization and mission creating a permanent predictable and autonomous source of revenue.

# The Innovation & Neighborhood Renewal Fund

The Innovation and Neighborhood Renewal Fund at the Community Foundation of Greater Fort Wayne was established in 2019 to support charitable activities related to research and development, educational programming, small business development and neighborhood revitalization for projects such as Electric Works in our community.

#### **Healthier Moms & Babies**

To create change and improve lives, we invest in local nonprofits and their clients. As a part of our competitive grants, we gave a \$25,000 grant to Healthier Moms & Babies in 2019. A grant to Healthier Moms & Babies is an investment in a prenatal home visitation program in which experienced home visitors and nurses are paired with a pregnant woman early in her pregnancy until the baby is 3 months old, providing prenatal health education, encouragement, and acting as advocates and mentors to our community's most at-risk pregnant women to support a healthy pregnancy and baby.



#### Board Education Speaker Talks (BEST Series)

The Community Foundation started the Board Education Speaker Talks or BEST series in 2018 and continued the series into 2019. The purpose of the BEST Series is to educate the Community Foundation board and staff about organizations doing great things in the community. One of the speakers in 2019 was Iric Headley from Fort Wayne UNITED. Fort Wayne UNITED advocates for and implements policies, practices and procedures to ensure equity and opportunity for black fathers, brothers and sons at home, work, school and in the community. At the firm, Dawn is the Director of Diversity, Professional Development and Inclusion. She inspired our legacy donors and guests to think differently about philanthropy, charitable giving and community engagement.

#### A Successful National Philanthropy Day

The Community Foundation participated in a National Philanthropy Day Celebration with the Association of Fundraising Professionals (AFP) at the Allen County War Memorial Coliseum. National Philanthropy Day is a celebration of philanthropy, giving, volunteering and charitable engagement, and to recognize the great contributions of philanthropy. On National Philanthropy Day, keynote speaker Dr. Lorenzo Suter energized the War Memorial Coliseum audience with his "I've Got Gas" message that was part biographical and definitely inspirational. Lorenzo is the CEO of Lutheran Health Network's DuPont Hospital. He is also an author and motivational speaker.



I am proud of the impact the Community Foundation made in our community this year. From opening a record number of funds, to the opening of Promenade Park and The Landing Phase I, to the continued



support of local nonprofits through our grantmaking and to assisting local students to attend college through our scholarship funds, this has been a banner year for helping others.

Additionally, we have laid a path for future endeavors through the completion of our Vision Plan. This outline encompasses six areas of focus: Connected Community, Inspiring Places, Everyone's Economy, Lifelong Learning, Healthy Mind and Body and Organizational Excellence. In this hour of unprecedented challenges, our vision of connecting people and resources to build a more vibrant community is more important than ever.
