



### ESG PORTFOLIO

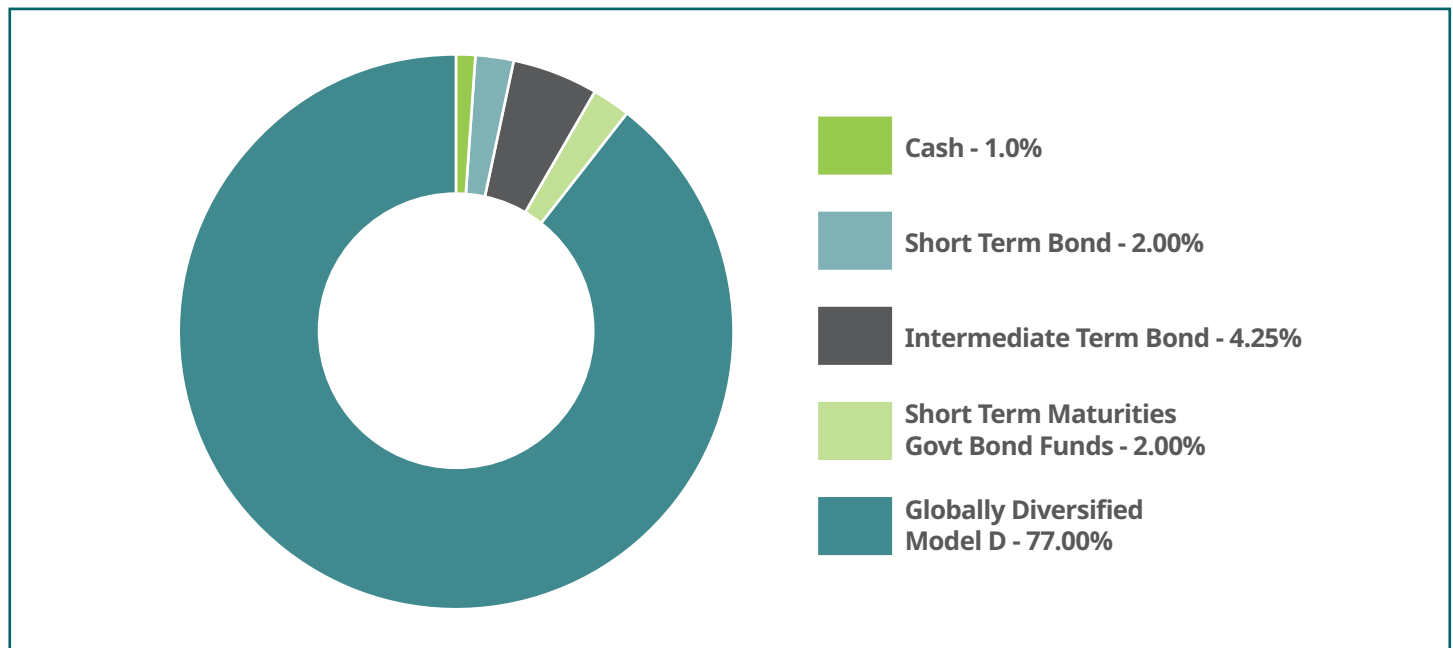
